It's Back To School Time! (and a great time for recycling)

The lazy hazy days of summer have now moved on to the cool crisp days of autumn and it's back to school time. Anne Arundel County Schools have reopened for the 2017-2018 school year. Now is a good time to once again think about recycling. Remember the three R's - Reduce, Reuse and Recycle.



Look for school supplies made from recycled products. Did you know that there are backpacks made from juice pouches, pencils made from recycled denim or newsprint, and notebooks, folders and binder paper made from recycled paper products?

Packing school lunches? Use reusable bags or boxes. Remind your children that many of the containers in their lunch boxes, including canned fruit containers, pudding tubs or juice cartons can be recycled. Buying lunch? Teach your children to take only what they need. Too often napkins, condiment packages like ketchup or mustard go to waste.

Attention Walnut Ridge Landlords

Landlord owners are obligated to provide their tenants with a written Lease or Rental Agreement which, among other things, indicates that the tenant must conform to the Covenants, Bylaws, and other documents of the Association. Landlords are also responsible to the Association for the actions of their tenants, since the tenants, just like owners, must also comply with the Covenants, Bylaws, etc. Landlords are responsible for maintenance or covenant violations committed by their tenants.

Landlords must--

- Notify the Association's management agent, ProCom (in writing) of the lease or rental period, names of the tenants, make and model of tenant vehicle(s) and contact telephone numbers.
- Inform the management agent of your mailing address while your home is being leased/rented so that Association correspondence may go directly to you. This is a requirement of Maryland law.

Landlords, please emphasize to your tenant the importance of abiding by the Association's Covenants, Architectural & Environmental Standards and the Parking Space Guidelines and provide copies to them. By doing so, it may avoid any misunderstandings, hard feelings and possible legal action when Management and/or the Board of Directors points out a non-conformance.

Anne Arundel County Launches New “3-1-1” Customer Service Program


In April 2017, Anne Arundel County launched its new 3-1-1 Customer Service Program which provides a telephone information center where citizens of Anne Arundel County can have their questions answered or be transferred to the appropriate department for concerns or problems. You can dial 3-1-1 Monday through Friday from 8:00 a.m. to 4:30 pm for help in finding the department you are looking for. Always dial 9-1-1 for emergencies.

You can also download the mobile app through the App Store (iPhone) and Google Play (Android). Only a simple signup process is required. Just touch the magnifying glass and search for “Arundel 311.”

Q: When are Board meetings held?

A: The Board of Directors typically meet on the third Wednesday of each month, except for July and December.

Q. Do I have to get approval for any exterior alterations/changes to my home?

A: **YES!** Each homeowner is required to obtain Association approval prior to making **any** exterior changes or alterations to their property. This includes, but is not limited to, painting, window and door replacements, railing installation, sheds and deck construction. A&E Application forms can be found under the Community Documents section on our website at www.walnutridgeonline.org. A correctly completed A&E Application will have attached all necessary details, sketches, plans, color swatches, etc. If you have any questions regarding the process, please contact the Board or management.



Ask the Board

Q: Do I have to pay the quarterly assessments?

A: Yes. If you are a homeowner in Walnut Ridge, you are required to pay all quarterly assessments. The current assessment is \$182 per quarter and is due on the first day of each quarter beginning January 1st.

Q: Will my mortgage company pay these assessments from my escrow account?

A: No, not typically. Mortgage companies generally do not escrow for these assessments. The homeowner is responsible for making these quarterly payments.

Q: I received a bill for a “Front Foot Assessment.” What is it for and do I have to pay it?

A: The Front Foot Assessment (also known as a Front Foot Benefit) is an annual charge (for a period of 30 years from the inception of our community) to pay back the costs incurred by the Developer for installing the water and sewer lines. Unless your front foot assessment has been paid in full either by you or the previous homeowner, you, as the homeowner, are responsible for this yearly invoice. The invoices are mailed each January and will come from either J & W Utilities or from Old Line Utility, LLC.

Q. Why did I get a Spring Inspection Deficiency Notice when my neighbor has several violations that aren’t getting fixed?

A: Don’t assume that because you see violations on other homes in the community that they haven’t been cited as well. If you’ve been cited for a particular violation, you can be sure that everyone else with the same issue has been cited. The Association and Management work with the homeowner to have those violations addressed and resolved so that property values will continue to rise and remain as high as possible


School Bus Safety - The Danger Zone

The School Bus Danger Zone is the area on all sides of the school bus where children are in the most danger of being hit. Children should stay 10 feet away from the bus (or as far away as they can) and never go behind the bus. They should take ten giant steps in front of the bus before crossing, so they can be seen by the driver.

The greatest risk is not when riding in the bus, but approaching or leaving the bus. While an average of 7 school-age passengers are killed in school bus crashes each year, 19 are killed getting on and off the bus. Most of those killed are children, five to seven years old. They are hit in the Danger Zone around the bus (See Sketch A below), either by a passing vehicle or by the school bus itself. It's illegal for a vehicle to pass a bus with its red lights flashing.

Young children are most likely to be hit because they:

- Hurry to get on or off the bus
- Act before they think and have little experience with traffic
- Assume motorists will see them and will wait for them to cross
- Don't always stay within the bus driver's sight
- Drop something as they get off the bus and run into the path of the bus to pick it up
