Back To School!

Anne Arundel County Schools have reopened for the 2008-2009 school year. It is again time to remind our residents to drive carefully and watch for children going to and from school.

Maryland law requires that when a school vehicle is stopping or has stopped on the roadway, and is operating the alternating flashing red lights, all vehicles must stop at least 20 feet from the front or rear of the school vehicle.

No one can proceed until the alternating flashing red lights have been turned off. Drivers should continue to exercise caution once the flashing lights have been turned off.

Drivers of other vehicles are not required to stop when they are on a divided highway and the school vehicle is on the other side of the divided highway.

Walnut Ridge Recycles!

At the recent General Meeting of the Walnut Ridge Community Association, Kristen Lagana from the Anne Arundel County Recycling Program gave a presentation on recycling in Anne Arundel County. Kristen explained the recycling process in Anne Arundel County and their goal to increase the amount of recycling.



Most of us are already recycling items such as cardboard, newspapers, junk mail, bottles, plastics and glass, but did you know that these items can also be recycled: empty paper towel and toilet tissue holders, shoe boxes, food/cereal boxes, pizza boxes, beverage cases, six pack holders, hard and soft cover books, magazines, telephone books, catalogs, gift wrapping, tissue paper, shredded paper, file folders, empty aerosol cans, detergent bottles and jugs—no need to rinse, include the lid!

There are a few items which cannot be recycled in Anne Arundel County. Those items are Styrofoam, aluminum foil, and waxed containers (such as orange juice cartons).

Kristen says that there is no need to look for the recycling symbol any more. Just put it in your bin if you're unsure.

Hazardous household waste may **not** be put out for curbside collection. These items should be dropped off between the hours of 8:00 am and 2:00 pm on these dates and locations: September 13th or November 15th at the Glen Burnie location (100 Dover Road) or on October 18th at the Millersville location (389 Burns Crossing Road). Hazardous items include oil-based paint, staining agents, gas and kerosene, solvents, pesticides, chemicals, propane tanks, asbestos/asbestos shingles, oil, antifreeze and many others. Below are some curbside collection tips from Anne Arundel County:

- Paper, cans, bottles and jars can all be placed in the same container for collection. Cans, bottles and jars don't have to be rinsed or cleaned! And you can include lids, caps and labels!
- Use the yellow recycling container or any other container of your choice marked with a large "X". You may put out an unlimited amount of recycling. Yellow recycling containers can be picked up at the Recycling Office at 2662 Riva Road, Annapolis between the hours of 8-5 Monday-Friday, or at any one of the Convenience Centers in Millersville, Glen Burnie or Deale.
- ◆ Yard waste should be bundled, bagged or put in containers and marked with an "X".
- To ensure your recyclables are collected, place them at the curb by 6:00 a.m. on Tuesdays. Note that if a holiday falls on a Monday or Tuesday, collection will occur on Wednesday. If a holiday falls on Thursday or Friday, collection will occur on Saturday.
- Keep recycling containers to 40 pounds or less.

LETTERS: WE GET LETTERS – Maybe other people's letters?

Are you receiving all the mail that you're supposed to get? There seems to be an alarming increase in the amount of misdirected or misdelivered mail over the past 6-months. At least twice a month, we find that the Mail Carrier has placed mail that's addressed to someone else in our mailbox. Sometimes the address is close (same number, different street) other times there is no similarity at all to our name or address. This is the fault of the Mail Carrier – who is supposed to be matching the full address and recipient's name with a given mailbox. It's really a big part of a Mail Carrier's job to do exactly that.



What happens if your mail is delivered to someone outside our Community – say, in Cape St. Claire or Broadneck - who may have an address that is similar to yours and who might not be inclined to make the trip to Walnut Ridge to deliver your mail? Then, you have to rely on the judgment of the person who actually receives your mail. Will they write a note on your mail and place it back in their mailbox for the Mail Carrier to see? Will they return it to the Post Office? Will they phone the Post Office to have it picked up? Will they accidentally open it? Will they just decide that it's probably 'junk' mail and just throw it away? Maybe you'll never know!!

If you receive someone else's mail, only you can decide what you'll do with it. Make the wrong decision and you could deprive the intended recipient of – say – a letter from Grandma, an employment opportunity, a refund check they've been waiting for, a credit card offer they actually want to respond to or something as mundane as a coupon they would have really liked to use. Remember, one person's junk might be another person's 'treasure'.

I suggest that we always treat misdirected mail as "Important" documents – and handle the item as you would want someone else to treat your own mis-directed mail. The easiest way to handle mail that isn't yours is to circle the address, write the word "re-deliver" next to it and place it in the outbound mail slot located in every Walnut Ridge Community mailbox. You may also phone the post office and they will advise you what to do with the mail. Generally they will send the Mail Carrier to your house to pick up the mail. Make certain that you ask for the name of whomever you talk to at the post office.

If the misdirected mail is too big for the outbound mail slot, again you can call the post office and they'll send the mailman back to pick it up. You can also give it to any Mail Carrier you happen to see (I recommend making a note of their name). You might want to take it down to the Post Office branch in Cape St. Claire shopping center (inside The Artist Flat store – not a full service USPS facility). If the weather is good, you might leave it on top of the Community mailbox (and, hope no one accidentally takes it). But, please don't throw away the misdirected mail.

Postal officials stress that it is important to report misdirected mail even if you bring misdirected mail to a neighbor yourself. This allows the managers to take steps to make sure mail gets to the right address. So, I encourage you to report every incident of misdirected mail. And, please encourage others to do the same whenever possible.

I notice that residents on Almond Drive have gotten together to reclaim the community property behind their homes that has been taken over by the trees and underbrush. What a great idea!

In previous newsletters I spoke about planting natural grasses around my house and decreasing the amount of lawn. After reading a recent article about lawns I changed my mind.

People studying habitats around the world recognize that lawns form a buffer and open space that allow us to be separate from the animal kingdom. Let's not invite them into our yards by leaving out food scraps that we actively spread out for them or by leaving food scraps and calling it "composting".

The passing of summer into autumn is a glorious time bringing with it Halloween, Thanksgiving and Christmas. I call it the best time of year.
