#### A Word From The President

Spring is nearly here and none too soon in this writer's opinion! We've made it through another winter and managed to somehow avoid much of the severity that other areas of the country have experienced.

Our community can look forward to some significant improvements in the coming months. Management is soliciting bids for a two-phase operation of repaving of our roadways, the oldest of which is approaching 40 years of age. The first phase of this is slated for this summer and the second phase will take place next year to complete the project. The actual dates of construction will be announced well in advance to allow for temporary parking during each phase. We will be restriping parking spaces, numbering, marking curbs for restrictive parking, and marking visitor spaces immediately following the repaving process of each phase.

Some replacement trees have been discussed and plantings in our common areas will continue to be maintained and enhanced as needed. At the direction of the Board, Management is also soliciting bids for improvement of the community playground and the possible expansion and addition of a new feature.

We have a new member on your Board of Directors and I would like to take this opportunity to welcome Rich Dugan as our newest Member at Large. Please be reminded that we are always looking for new faces, new ideas, and participation in the decisions relating to the operation of the community.

Finally, please be reminded of two issues that continue to crop up. One relates to residents who operate more than two vehicles and use

the few "Visitor" spaces available for their additional vehicles. This practice prevents the use of these spaces for legitimate visitors and must not continue. Those that continue to do this may receive a written warning sticker followed by the vehicle being removed by our towing company. Please do not merely move the vehicle from one "Visitor" space to another, thinking that towing will not occur. Our community can only accommodate two cars per household and those residents with additional vehicles will simply have to find other places to park.

The other issue has to do with trash collection. We have all received notice from the Dept. of Waste Management that recycling will only be collected if left in approved containers. There has also been a redefinition of waste that will be accepted as recycling. As an example, plastic bags or anything left in plastic bags will not be collected. This includes recycle materials that are placed in a plastic bag in a recycling can. The can will just be ignored and will not be emptied.

Yard waste (tree trimmings, grass clippings, etc.) must be left in an approved paper bag. These are available at many local hardware and grocery stores. Plastic bags marked with an "X" will no longer be picked up.

Finally, please leave your trash out the evening before pickup and in approved cans with tops and **marked** with your house number. Please store your emptied containers the day of collection or the morning following. Trash that is left out for collection in cans without tops or in plastic bags alone are easy targets for birds, vultures, and rodents. Please don't continue to do this! It seriously detracts from the appearance of our community. Thank you for your cooperation!

#### **NEWS FROM THE BOARD**

At the reconvened Annual Meeting on Wednesday,
 February 6, 2019 at Broadneck Library, all Board members were reelected to another term. Rich Dugan was elected as Member at Large.



- Bids are being considered for playground repair and enhancement.
- Proposals are being considered for replacing the asphalt on our streets, to include striping, marked parking and curbs. The Board will also be considering bids for sidewalk, curb and road gutter cleaning and re-caulking of the sidewalks.
- Reserve Study will be done after the asphalt replacement has occurred.
- Spring inspections will again be conducted by CIS Inspection Experts.
- Attention to unauthorized parking in visitor spaces and in marked resident spaces.
- Cat Branch Stream Restoration. The project is ongoing by Anne Arundel County on lower Peach Court and Walnut Ridge Drive.

#### FROM THE A&E COMMITTEE

Every resident (owners and renters alike) should have a copy of the Walnut Ridge Architectural and Environmental Standards. A copy of the A&E Standards can be found on the Walnut Ridge website <a href="www.walnutridgeonline.org">www.walnutridgeonline.org</a>. Here are a few key points the Board would like to remind you about:

- An A&E Application must be completed in writing and submitted to the Management Company for any exterior alteration, addition or new construction. Be sure to include with your completed Application:
  - two copies of your Application,
  - a copy of your site plan, sketches, plat with dimensions of your project,
  - once completed, your Application with all enclosures/attachments should be either mailed to ProCom Management, 400 Serendipity Drive, Millersville, MD 21108, or sent by email to <a href="mailto:Board@walnutridgeonline.org">Board@walnutridgeonline.org</a>.
- Any exterior alteration, addition or new construction must be approved, even when a similar or substantially identical alteration, addition or new construction had been previously approved.
- Fences of any style must be approved before construction begins.
- Awnings on windows, doors, and decks are not permitted without express written consent of adjoining neighbors and committee approval.
- Exterior clothes lines are not permitted.

Walnut Ridge is again participating in the Anne Arundel County Community Clean-up Program. A dumpster is tentatively scheduled to be available in the Cul-De-Sac by 12 noon on Monday, April 29, 2019, and will be picked up by 12 noon on Wednesday, May 1, 2019. In accordance with the AA County Community Clean-Up Guidelines, do not place items outside of the dumpster, or place prohibited items in the dumpster. Prohibited items are:

Junk automobiles Liquids Hazardous Waste Refrigerators

Trailers Air Conditioners/Freon

**Boats** Items

Gas & Propane Tanks Metal Items Tree Trunks/Logs Cardboard **Batteries** Paper

Oil Drums or Tanks Plastic or Glass

Paint

For proper disposal of the prohibited items listed above, please call the County at 410-222-6108.

The dumpster will be monitored for misuse, so please do not abuse this privilege.

## Items Accepted for Recycling

- PAPER examples include: Milk & juice cartons/boxes
- Cardboard
- Boxes (cereal, cracker, frozen food, shoe, pizza, etc.)
- · Books (hard and soft cover)
- Sheets & pads of paper
- Newspaper & inserts
- Junk mail & envelopes
- Magazines & catalogs Folders & notebooks
- Photo paper

#### METAL - examples include:

- Aluminum foil & pans
- Aluminum cans
- Tin/steel cans
- Empty aerosol cans

#### PLASTIC - examples include:

- · Bottles, jars, jugs, tubs & trays
- Plastic cups, plates, utensils
- Plastic buckets & flower pots
- Storage totes
- Plastic furniture
- Plastic laundry basket
- Trash cans & old recycling containers
- Plastic toys, pools & playsets

#### GLASS

Bottles and jars (any color)

Unbag your recyclables. Place paper, plastic, metal, and glass items loose inside your recycling container.

Return clean, dry plastic bags to a local grocery or retail store or County Recycling Center for recycling.

#### **RECYCLING TIPS**

- · Put all recycling into the same container, there is no need to separate.
- · You do not need to rinse or clean recycling and you can include labels, caps, and lids.
- · You may put out an unlimited amount of recycling.
- Use the yellow recycling container or any other container of your choice marked with a large 'X'.
- · Place large recycling items next to your recycling container.
- When in doubt about an item, give us a call at 410-222-7951.
- Place yard waste in kraft paper bags or reusable containers (marked with an "X") or tie into bundles.
- To avoid confusion, do not use yellow recycling containers for yard waste.

#### Reminder to Walnut Ridge Landlords

Landlord owners are obligated to provide their tenants with a written Lease or Rental Agreement which, among other things, indicates that the tenant must conform to the Covenants, Bylaws, and other documents of the Community.

Landlords are also responsible to the Association for the actions of their tenants, since the tenants, just like owners, must also comply with the Covenants, Bylaws, etc. Landlords are responsible for maintenance or covenant violations committed by their tenants.

Landlords: Please provide to your tenant(s) a copy of: (1) the Association's Covenants, Architectural & Environmental Standards, and (2) a copy of the Parking Space Guidelines. Please emphasize to your tenant(s) the importance of abiding by the rules outlined in these documents. By doing so, it may avoid any misunderstandings, hard feelings and possible legal action when Management and/or the Board of Directors points out a non-conformance.

And finally, as a Landlord, you must--

- Notify the Association's management agent, ProCom (in writing) of the lease or rental period, names of the tenants, make and model of tenant vehicle(s) and contact telephone numbers.
- Inform the management agent of your mailing address while your home is being leased/rented so that Association correspondence may go directly to you. This is a requirement of Maryland law.


#### WIPERS ON—LIGHTS ON



#### **Kindergarten Registration begins April 3, 2019**

Before your child can enter kindergarten, be sure to:

- 1. Determine Student's Eligibility: Children must be five-years-old by September 1 to enroll in kindergarten.
- 2. Identify and contact the school: You should register at the child's local school. To determine what the local school is for a specific address, check the School Assignment Locator or call The Planning Office at 410-439-5683.
- 3. Verify age, identity, residency, and immunization compliance: Parents/Legal Guardians registering their children in an Anne Arundel County Public School must provide proof of student's age, identity, county residency and immunizations, unless homeless. Additionally, immunizations must be up to date.


## A Word From The Walnut Ridge Wanderer
