Greetings From The President

Welcome and greetings to all new and continuing residents in our community. Your Board of Directors remains actively involved in the effort to maintain and improve Walnut Ridge as spring weather transitions into summer 2017. Our ProCom management team has completed Spring Inspections and should be mailed out by Monday, the 12th. To those folks already aware of existing deficiencies, the Board requests your compliance as soon as possible. To those conscientiously maintaining the exterior condition and appearance of their homes, we extend a word of thanks for helping to insure value and appearance of the community as a whole.

Please be reminded of a few issues that continue to crop up:

1. Trash, recycle bins, children's toys, and personal items are not to be stored at the front of your home or outside your property line. If you have a border fence, please understand that community property is on the opposite side and in many cases is not only visible to all, but is maintained at the community's expense.
2. Yard waste such as grass clippings is now required to be placed for pick up in an approved paper bag. Waste placed in green plastic bags, marked with an "X" will no longer be accepted by the service. The approved bags are available at any hardware store. Larger yard waste such as shrub pruning or tree trunks, branches

and the like may not be dumped outside your property or on that of the community. Household trash and recycle materials are to be placed on the asphalt and as close as possible to your designated parking spaces. Please do not place them on community plantings, mulched planting beds, or the grass. Also be reminded that the placement for pickup is to be no earlier than Monday afternoon and removal of emptied receptacles no later than Tuesday evening. Receptacles, tops, materials placed out late and not picked up at all give the whole community a shoddy appearance that I know, none of us want. Please cooperate with this effort and remove the empties as quickly as possible. It is much appreciated by all!

3. With very few exceptions, all parking in Walnut Ridge is perpendicular to the curb. Please be cognizant of the distance between your tires and the curb to avoid an unintentional hindrance to public use of the sidewalk.
4. Please observe the pet leash laws in our county. Allowing cats to feed and freely roam outside is illegal, and by the standards of today is inhumane. Leaving pet food outside also actively promotes the growth of a wild rat population that has been reported here and in neighboring communities.

In closing, please be reminded of the seasonal initiation of the 2017 A.A. Co. Mosquito Control Program. Our community has been scheduled for spraying on Wednesday evenings throughout the summer months. Please read the information left on your doorstep and/or included in this publication. Your Board of Directors wishes you all a safe and enjoyable summer season! Thank you.

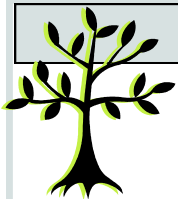

Sunglasses - THEY'RE MORE THAN A FUN FASHION ACCESSORY!

According to the National Eye Institute, the most important job of sunglasses is to protect your eyes from the sun's ultraviolet (UV) rays. Some of the sun's effects on the eyes include:

- Cataracts, a clouding of the eye's lens that can blur vision. An estimated 20% of cases are caused by extended UV exposure.
- Macular degeneration, resulting from damage to the retina that destroys central vision. Macular degeneration is the leading cause of blindness in the United States.
- Pterygium, a tissue growth over the white part of the surface of the eye that can alter the curve of the eyeball, causing astigmatism.



When purchasing sunglasses, look for ones that are polarized, block out 99 to 100% of both UVA and UVB radiation. A wide-brimmed hat offers great protection, too!

Thunder and Lightning

Thunderstorms are most likely to happen in the spring and summer months and during the afternoon and evening hours but can occur year-round and at all hours.

All thunderstorms produce lightning. Here are some Lightning Myths and Facts:



MYTH: If it is not raining, then there is no danger from lightning.

FACT: Lightning often strikes outside of heavy rain and may occur as far as 10 miles away from any rainfall.

MYTH: The rubber soles of shoes or rubber tires on a car will protect you from being struck by lightning.

FACT: Rubber-soled shoes and rubber tires provide NO protection from lightning. However, the steel frame of a hard-topped vehicle provides increased protection if you are not touching metal. Although you may be injured if lightning strikes your car, you are much safer inside a vehicle than outside.

MYTH: People struck by lightning carry an electrical charge and should not be touched.

FACT: Lightning-strike victims carry no electrical charge and should be attended to immediately. Contact your local American Red Cross chapter for information on CPR and first aid classes.

MYTH: "Heat lightning" occurs after very hot summer days and poses no threat.

FACT: What is referred to as "heat lightning" is actually lightning from a thunderstorm too far away for thunder to be heard. However, the storm may be moving in your direction!

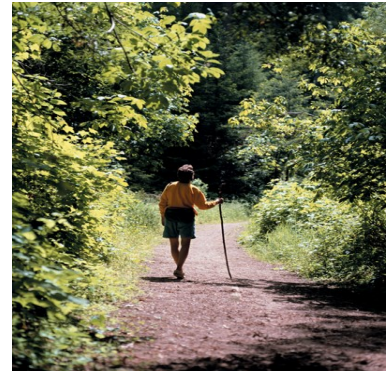

PLEASE SHARE THIS INFORMATION WITH YOUR COMMUNITY

- Your Community's assigned spray night is: **Wednesday**
 - Your community will only ever be sprayed on Wednesday nights during the 2017 season
- Spraying can occur anytime between 7:00 PM and 2:30 AM
 - The spray program will begin on May 31.
 - Spraying will not begin until the community has been notified and we have received the Community Notification Verification Form
 - October 3 is the estimated last day of spraying for 2017
- Residents who do not wish their property to be sprayed may file an exemption. The exemption policy and form can be found on our website:

- On your community's assigned spray night we suggest the following precautions:
 - Stay indoors
 - Shut windows
 - Turn off window air conditioning units
 - Bring in pet dishes, children's toys, etc.

STANDARD MOSQUITO CONTROL OPERATING PROCEDURES – 2017

OPERATING PROCEDURES FOR SPRAYING OF ADULTICIDES (Treatment for adult mosquitoes):

- **Regular Surveillance and Control of Adult Mosquitoes: May 31 – October 3**
Sunday-Thursday (A night of the week will be assigned to your community)
Anytime between 7:00p.m. - 2:30 a.m.
- Spraying for adult mosquitoes will be **done only if a Maryland Department of Agriculture Employee determines it is necessary.**
 - Spraying **will not be conducted** during rain, in wind speeds exceeding 12 MPH, or temperatures above 89°F.
 - **Thresholds for Ground Based ULV Treatments:**
 - Landing Counts: 3 mosquitoes in a 2 minute count
 - Light Trap Collections: 12 female mosquitoes in an unbaited light trap
24 female mosquitoes in a baited light trap
 - Conditions that threaten public health, such as mosquito borne disease

OPERATING PROCEDURES FOR USE OF LARVICIDES (Treatment for mosquito larvae):

- **County-wide Surveillance and Control of Larval Mosquitoes: April - October**
Monday – Friday, 8:30 AM -4:00 PM
- **LARVICIDES TO BE USED:**

<u>Bacterial Larvicides:</u>

- The Mosquito Control Program does not spray for Midges that swarm on homes, boats, trees and shrubs along many Anne Arundel County creeks and rivers. These non-biting insects develop in mud bottoms of slow moving water ways of low dissolved oxygen and will decline in numbers within a few weeks after they first appear.

MOSQUITO CONTROL POLICY STATEMENT

OBJECTION TO ADULT MOSQUITO CONTROL

The policy of the Maryland Department of Agriculture regarding an objection to adult mosquito control by truck-mounted ultra low volume (ULV) application of insecticides is as follows:

! An individual may have his/her owned or leased real property and a surrounding buffer up to 300 feet on all sides of the property excluded from ground based ULV adult mosquito control.

! Each individual requesting this exclusion must submit the request in writing to the Maryland Department of Agriculture and provide copies to the appropriate community association or city/town. The request must provide the address of the property to be excluded and must be signed by the owner(s) or leasee(s). This request will be acknowledged in writing by the Department.

! If the number of individual objectors and the location of excluded properties precludes an effective mosquito control adulticide service in a community, the service in that community will be suspended. Service may be reinstated upon the written request of the community and approval by the Department.

! A city/town or community association may request the Department to rescind or modify a spray exclusion zone if the local authority believes the exemption unfairly impacts other residents who desire adult mosquito control service. Requests to rescind or modify spray exclusion requests must be made in writing and delivered to the Secretary of Agriculture.

! The Department periodically will verify the continued occupancy/ownership by objectors of properties excluded from ULV ground spraying to determine if the objection continues.

! In the event of mosquito-borne disease or conditions that threaten public health, the suspension of mosquito adulticide service in an area due to objectors will be discontinued and the full range of mosquito control procedures available will be utilized.

PUBLIC INFORMATION NOTICE:

Your **request for exemption from adult mosquito control services** by the Maryland Department of Agriculture **WILL NOT** be processed unless **ALL** of the information requested has been supplied. You have a right to inspect, amend, or correct this information. Under State Government Article, 10-617, Annotated Code of Maryland, this information may be generally available for public inspection. This information is not routinely shared with state, federal, or local government agencies.

REQUEST FOR EXEMPTION FROM ADULT MOSQUITO CONTROL SERVICES

This application must be completed by the individual residing within a community participating in the Mosquito Control Program who wishes to have his/her property excluded from adult mosquito control pesticide applications by truck-mounted ultra low volume (ULV) sprayers. The attached statement entitled "Objection to Adult Mosquito Control" explains the Maryland Department of Agriculture's policy on individual objectors. Please retain it for your files.

Please read the "Public Information Notice" on the attached policy statement. **Exemptions will not be accepted unless all of the information requested has been supplied. Failure to respond to contact from MDA will result in the voiding of your exception. It is your responsibility to notify MDA should your contact information change.** Thank you for your cooperation in this matter.
